

**SPECIAL OLYMPICS SOUTHERN CALIFORNIA
RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY,
AND PARENTAL CONSENT AGREEMENT
("AGREEMENT")**

In consideration for participating in the Special Olympics Southern California Torch Run ("Activity"), I represent that I understand the nature of the Activity; and that I am qualified, in good health, and in proper physical condition to participate in the Activity. I acknowledge and agree that, if I believe Activity conditions are unsafe, I will immediately stop participating in the Activity.

I am participating at my own risk. I fully understand that the Activity involves risks of death and serious bodily injury, including permanent disability and paralysis. I understand that such risks may arise out of my actions or inactions, the actions or inactions of others (including the negligence of the "Releasees" named below and negligent rescue attempts or operations), the conditions in which the Activity takes place, or some combination of the foregoing. I understand that there may be other risks either not known to me or not readily foreseeable at this time by me or the Releasees. I fully accept and assume all risks and all responsibility for any and all injury, losses, costs, and/or damages that I may suffer arising out of attending, participating in, and/or watching the Activity.

I will not sue anyone if I am injured or killed. I release, discharge, hold harmless, and covenant not to sue Special Olympics, Inc., Special Olympics Southern California (including their respective administrators, directors, agents, officers, volunteers, and employees), other participants, bystanders, sponsors, advertisers, donors, or if applicable, owners, lessors, or managers of the premises on which the Activity takes place or the equipment used during the Activity, (the "Releasees") from all liability, claims, causes of action, demands, losses, or damages caused or alleged to be caused, in whole or in part, by attending, watching, or participating in the Activity. I agree that if I, or anyone acting on my behalf, makes a demand, claim, or files suit against any of the Releasees, then I will defend, indemnify, save, and hold harmless each and all of the Releasees from any loss, liability, damage, or cost incurred as a result, including attorneys' fees.

I have read this Agreement carefully. I understand and agree that I am giving up substantial rights by signing this Agreement, and I have nevertheless signed it freely and without any inducement or assurance of any nature. This is a complete, integrated agreement; no part of it is unwritten. I intend this Agreement to be a complete and unconditional assumption of risk and release of all liability to the greatest extent allowed by law. Any ambiguity in this Agreement is to be construed in favor of the Releasees. I agree that if any portion of this Agreement is held to be invalid the balance will continue in full force and effect.
